SHORT COURSE:

This event includes a dressage test and jumping event. The jumping event consists of a shortened show jumping course and shortened cross country course combined.

COMBINED TRAINING:

This event includes a dressage test and a full length show jumping course. If competing in both events, dressage test score from horse trials/short course will be used (one dressage test). Combinations competing in both events must be same grade for Horse Trials and Combined Training or only enter one event.

SCORING:

There will be no equal first place. For first place ONLY count back methods as outlined in PCAV rule 37.2, 37.3 and 37.4 shall be used.

Conditions of Entry:

Entry is conditional upon acceptance of these conditions:

- **Pony Club Grade 6 Pony Club must be graded by their DC on their card.**
- **OPEN BEGINNERS DRESSAGE 5A TEST Competition (only if not competing in Horse trials or combined training).** As per PCV rules upgraded riders are not able to compete.
- **Limited yards available at \$10 –Please confirm availability before paying. Bookings to: Vicki – 0417 147 695**
- Entering this competition constitutes acknowledgement and acceptance that 2018 PCAV rules apply.
- The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
- No refunds after closing date except with vet or medical certificate. An administration fee of \$10 will be deducted.
- Current PCAV, EA/EV, AHSA, AERA, HRCV, or SHCA Membership Cards must be presented to the Secretaries Office before riding. No Card, then you will need to pay \$10 day participation and complete form.
- OPEN RIDERS who do not have adequate Insurance Cover must complete the Day Participation Form and pay \$10.
- ALL OPEN RIDERS must fill in the Liability Declaration Form.
- Back numbers provided. Bridle and saddle number acceptable for Dressage and Showjumping but back numbers must be used for Cross Country/Short course component. All back numbers must be returned to clubrooms before leaving event. Membership card may be left for deposit on back number.
- Open Riders to ride the Show jumping in Jacket or Club uniform, and Jodhpur colour for this event is as per PCAV Uniform rules.
- Riders may enter in short course AND Combined Training events on the same horse. Placings will be determined as per PCAV Horse Trials Rules 2018. Any rider under the age of eight years may not compete in short course but may compete in combined training.
- Multiple Horse Participation Refer 34.8 ii in handbook by laws PCAV.
- Gear check is required for all riders, and before each phase.
- Medical armbands will be inspected at gear check to ensure compliance and is required by all riders.
- Correct 'standards' numbered helmet must be worn as specified in PCAV Gear Rules. Spot checks may occur and incorrect helmet will mean elimination.
- Lunging is NOT PERMITTED
- Horses must be at least age four, no stallions, colts or rigs.
- Queries, protests, horse abuse and doping rules as per the PCAV Handbook of By-Laws.
- Alcohol Policy: officials and riders are not permitted to consume alcohol eight hours prior or during the competition. Under-age drinking is not permitted.
- Neither the organising committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property. Kyabram Pony Club Inc. Registered Association: No A0004876K
- Camping will be available in designated areas at \$10.00 per night/per family and must be paid with entry form. No Powered sites available.
- PCAV By-Laws rule 2017 Stabling and yards should be of solid construction. The use of electrified tape, strings, ropes or chains, is not permitted at Pony Club Event Electric tape can be used as a top line or as a "standoff" on a steel or solid yard, but not as a standalone yard.
- All Competitors are advised to have their own Ambulance cover (Open riders should also have their own personal accident cover)
- Each rider MUST provide one cross country judge.
- STRICTLY NO DOGS ALLOWED. Bringing a dog onto the grounds will result in elimination for the associated rider.
- **Medical Response Authority & Horse/Veterinary Authority needs to filled out and brought with you on the day.**
